Who Can Vote

Only a Hillsboro Food Co-op **member-owner in good standing** may vote. Each member-owner shall have only one vote on each issue submitted to a vote of member-owners.

- Good standing is defined in the Co-op's Bylaws and is judged as of Saturday, April 13, 2019.
- Voting by proxy is not permitted.
- We cannot accept two ballots from one member-owner, although you may submit a subsequent ballot if you note on the envelope that it **supersedes** your previous ballot.

How To Vote

There are two ways in which to submit your ballot:

- 1) Mail-in: Member-owners are encouraged to vote via mail-in ballot if they are unable to vote in-person at the Annual Meeting.
 - For a mailed-in ballot to be valid it must be:
 - **o** Signed by the member-owner.
 - o Mailed in a sealed envelope to Hillsboro Food Co-op, P.O. Box 3953, Hillsboro, OR 97123
 - Postmarked on or before Wednesday, April 10, 2010. We will not accept postage-due ballots.
- 2) At the Annual Meeting: Even if you don't intend on staying for the breakfast or business meeting, you can stop by and drop off you ballot.
 - Date: Saturday, April 13, 2019
 - **Time:** 9:00 am to 12:00 pm
 - ♦ Location: Hillsboro United Methodist Church, 168 Northeast 8th Avenue, Hillsboro
